212 PRIME CATTLE

A larger entry as expected met a difficult trade which was also anticipated. A ring full of cautious buyers were very selective in their choice of purchase with lean saleable carcasses holding values more easily than cattle that were too fat, small, large or nor meaty enough. It was obvious from the type of cattle forward that producers have a need to sell beasts that were plenty fat enough in many cases.

Best steers sold in front of dead quotations and to be fair, we had a sprinkling of these penned. Quality heifers were harder to source and sold to 256p/kg. Cattle which were a shade too fat were hard to sell with no wholesale demand.

Bull trade held up quite well with seemingly demand for lean but fleshed Holsteins at a price. Again, there were few Continental bulls forward and a large compliment of Holsteins. Many bulls were over 16 months up to 31 months old.

27 COWS SOLD TO OV. AV. 110P/KG

Cows were dearer following on from last week's rise. Demand for this cheaper product saw strong bidding for all types.

Meated British Blues from Steve Perkins sold to 140p/kg and 138p/kg. Good square Friesians sold to 134p/kg from Henry Yates. Holsteins to £1187.92 from James Tudor. Pure Charolais sold to £1300 from Richard Pugh. Boning cows sold to similar values from 60p/kg – 85p/kg.

143 CLEAN CATTLE

38 steers sold to average 180p/kg. A high of 215p/kg was achieved for 626kg Blonde from Martin Osborne. 612kg British Blues from Peter Raybould sold to 214p/kg, closely followed by Lims from Sparchford at 210p/kg (x2). Angus sold to 201p/kg from Coppice Farm. Plain and/or non FABBL cattle sold to an easier trade.

105 heifers sold to an overall average of 186p/kg. A super run from Richard Parkes regularly passed 240p/kg to a top of 256p/kg for 524kg Limousin. 602kg Blondes from Martin Mottershead sold to 229p/kg, with 500kg Lims to 227p/kg from Stuart Bebb. 472kg Charolais sold to 224p/kg from Dave Chilton.

69 YOUNG BULLS SOLD OV AV. 145P/KG

There were 8 suckler bred bulls forward, 5 of which were over 16 months. Roger Tomley's Lims and Blues took the honours at 207p/kg and 205p/kg for 526kg and 602kg. 614kg Blonde sold to 195p/kg for Forest Vale Growers.


